The San Diego County Air Pollution Control District's publications, notices, reports and any periodic updates to these items may be acquired in several ways:

1. Purchase or Renew Over-the-Counter or by Mail. Complete Publication Order Form and forward with check or money order to Publication Services, APCD, 10124 Old Grove Road, San Diego, CA 92131. Please call (858) 586-2600 if using a credit card for payment (American Express & Discover cards only). An order form is still required when paying by credit card. **Purchase orders, C.O.D. or post-dated checks are NOT accepted, and NO refunds are given.** Subscriptions are offered on a calendar-year basis and are renewed in January of each year. There is no prorated rate for partial years, and **no refunds** are given on any unexpired portion of the subscription. All current subscribers receiving this order form must return it with payment for their subscription to continue.
