Monique will be helping implement the Community Air Protection Program and collaborate with the Office of Environmental Justice. Monique will be reaching out soon to set up one-on-one meet-and-greet conversations with the CSC members.
 - ii. The Port of San Diego announced they will be hosting their annual South Bay Holiday Party at the National City Aquatic Center on Wednesday, December 7 from 5PM – 8PM. The Port will provide shuttle services to the event location from Paradise Creek Apartments and the National City Library.

 - b. **Chuy Flores** reviewed the proposed 2023 meeting calendar based on the November survey results. Meetings will tentatively be held in-person (hybrid) once a quarter starting February 2023 with alternating locations between Barrio Logan and National City. All other meetings will

remain virtual over Zoom.

- c. Questions and Comments
 - i. **Sara Giobbi** flagged that we have seen folks not showing up and suggested possibly checking in with folks as we go into the new year to ensure those who are interested are able to make the meetings.
 - (A) **Chuy Flores** suggested that this could be part of the work Monique and the facilitation team do as part of one-on-one check-ins with Steering Committee members.
 - ii. A committee member asked if Zoom will still be available for the in-person meetings.
 - (A) **Chuy Flores** responded that for the hybrid meetings, the plan is to have a Zoom option available during the in-person meetings.
 - iii. **Sara Giobbi** flagged if the translation services have been overcome for the hybrid meetings.
 - (A) **Chuy Flores** noted that this is still something the team will have to account for and SDAPCD will think through to how to make it work best.
 - iv. **Domingo Vigil** added that they will take all considerations into account and work to make the meetings next year productive, especially for the hybrid transition. Folks are encouraged to continue to send feedback and suggestions to the team.

IV. Presentation: MCC Bulk Cement Warehouse and Loading Facility (Port of San Diego) 5:30 pm

- b. Mitsubishi Cement Corporation (MCC) staff and Port of San Diego Staff presented an overview of the proposed bulk cement warehouse and loading facility project and its alignment with the Maritime Clean Air Strategy (MCAS) and Portside Community Emission Reduction Plan (CERP) goals.
- c. Questions and Comments
 - i. **John Alvarado** noted that on behalf of himself and Steve, a long-term Barrio Logan resident, they support this project as it will provide jobs that the community needs. John believes MCC will abide by the rules and supports a project that provides core values, education, and good jobs.
 - ii. **Monique G. Lopez** asked if Mitsubishi's operations would decrease at the Victorville Plant if the project were to move forward and if there is a commitment from Mitsubishi to do so.
 - (A) **Austin Marshall** responded that the demand in California and Nevada right now far exceeds the supply, and the team is trying to catch up. They do have customers coming from San Diego to the high desert to pick up cement and they are trying to eliminate that traffic. In a way, this project would decrease operations, but it all depends on market conditions.
 - iii. **Monique G. Lopez** asked if Mitsubishi has been engaging with the Department of Transportation (Caltrans) to coordinate on the larger goals.
 - (A) **Marcia Baverman** responded that they have two sites, one for domestic which is located in the high desert and an international import site which is located in Long Beach.
 - iv. **Larry Emerson** agreed with John's earlier comment about local job creation. He also asked what plans Mitsubishi has for EV charging infrastructure for both its employees and heavy-duty vehicles coming in and out of the facility. Additionally, Larry asked what Mitsubishi is doing to help make green concrete.
 - (A) **Austin Marshall** responded that should they move forward with the facility, then they do plan to have EV charging stations for its employees, however, as for their customers driving the zero-emission trucks it will be up to them to install the



charging stations in their own plants. It wouldn't make sense for them to charge their trucks while loading the cement. As for the cement, Mitsubishi is currently producing cement that reduces carbon dioxide and they hope to implement something similar with their customers whom they receive cement from. Mitsubishi is also looking into solar projects involving waste heat recovery, which is where you're taking heat used to process the cement and turning that into steam that goes through turbines and makes electrons. The carbon injection into ready-mix is a twofold process that's more of their customers' responsibility because Mitsubishi doesn't make the concrete or ready-mix, just the cement. Mitsubishi is currently working on a years-long project to help use carbon dioxide and put it into materials that can sustain it. It's a large company goal that will require an agreement with its customers.

- v. **Philomena Marino** asked how Mitsubishi is working to enforce the truck route rules.
 - (A) **Austin Marshall** responded that although they are not tenants yet, Mitsubishi is being proactive and making sure they have good relationships with their customers to ensure enforcement of these rules.
 - (B) **Valerie Martinez** added that they are working with Councilwoman Moreno's office to figure out how Mitsubishi can partner in accessing funding to accelerate the Harbor 2.0 Truck Route as well as looking into additional funding resources.
 - (C) **Philomena Moreno** followed up by asking what Mitsubishi is doing to enforce that their employees use public transportation instead of using up residential parking.
 - a. **Austin Marshall** responded that this is not something Mitsubishi is aware of, and they are willing to look into it should they become tenants.
- vi. **Domingo Vigil** asked if the zero-emission goals Mitsubishi plans to incorporate have been shared already and if not when they plan to share those goals.
 - (A) **Michael Lafleur** responded that Mitsubishi has been working with the Port of San Diego to commit to the same goals and objectives as the Maritime Clean Air Strategies which include aggressive air emissions reductions.
 - (B) **Maya Grasse** added that those are the concepts that Mitsubishi and the Port have agreed on and the concepts they are incorporating include specific measures for the zero-emission MCAS goals. For example, one of those goals is the use of zero-emissions trucks when they're available. The MCAS recognizes that certain charging infrastructure needs to be ready for that to happen. Mitsubishi is in discussion with the Port on including language in the lease that include addition emissions reduction, so that even if there's not enough infrastructure for zero emission trucks, Mitsubishi will be required to achieve equal emissions reductions through other means.
 - (C) **Nicki Carlsen** added the goal of both Mitsubishi and the Port is to get that language out to the community well before December 13th.
- vii. **Domingo Vigil** asked if Mitsubishi plans to tie the Emissions Reduction Plan to the lease and what the timeline looks like if so.
 - (A) **Maya Grasse** responded that it will be incorporated into the lease and the lease will spell out the different ways by which concrete emissions reduction can be achieved.
- viii. **Tim Garrett** asked if the team has overcome the shore power requirement.
 - (A) **Marcia Baverman** responded that the shore power requirement is a limit of the dried-off breaker on the ship.
 - (B) **Austin Marshall** clarified that their cruise business is not using shore power but rather a dry dock breaker that runs like an extension cord versus a power line



- from the utility.
- ix. **Tim Garrett** asked if Mitsubishi could share more about the customer demonstration project.
 - (A) **Austin Marshall** indicated that they have some customers that have already stepped up to participate in the demonstration project which would show the trucks that are available along with use, distribution range, weight distribution, and more.
 - x. **Nick Paul** asked how Mitsubishi will enforce the use of trucks' newest vehicles and how many jobs they will bring to Barrio Logan.
 - (A) **Marcia Baverman** indicated that they currently keep a running ledger of the inventory to track and ensure that the vehicles stay within the restriction of five years or newer.
 - a. **Austin Marshall** added that the big customers typically don't have a fleet of over five years.
 - b. **Maya Grasse** added that in addition to keeping a ledge, there is also court oversight as part of the mitigation measure.
 - (B) **Valerie Martinez** indicated that bringing cleaner cement directly into the Port of San Diego will support hundreds of construction jobs as a result of having the local source of cement.
 - xi. **Paula Forbis** asked for clarification regarding the final release of the EIR and other actions that will be coming to the Port Board at the December 13th meeting.
 - (A) **Megan Hamilton** clarified that the actions that will be brought to the Board on December 13th include the final subsequent Environmental Impact Report (EIR), a draft CDP, project concept approval, and the lease terms. The EIR will be released on December 2nd prior to the Board meeting. The Port expects all other related documents to be released the Thursday before the Board meeting or earlier.

 - i. **Joy Williams** commented that there was a lot of information presented and not a lot of firm commitment. Joy proposed a motion for the Steering Committee to approve the letter and oppose the MCC project at this time.
 - (A) Motion seconded by **Philomena Moreno**.
 - ii. **Phil Gibbons** clarified if the Steering Committee would have a meeting in December.
 - (A) **Chuy Flores** clarified that there will not be a CSC meeting held in December.
 - (B) **Phil Gibbons** suggested the CSC structure the motion to have members review the lease language once released before moving to a full opposition motion.
 - iii. **Jack Monger** opposed the motion and offered a substitute motion suggesting that the CSC hold a special meeting in December to discuss the missing documents or ask the Port to delay their consideration until the CSC has had a chance to review all the information once documents have been released.
 - (A) Substitute motion seconded by **John Alvarado**.
 - iv. **Margarita Moreno** commented that she also opposes the MCC project given the negative impact it will bring to the local community.
 - v. **Maritza Garcia** commented that Mitsubishi came two years ago with a similar



proposition that was opposed and after two years it still seems like a lot of empty words. It is the reason why several community members oppose the project and stands in opposition.

MOTION 2 (Substitute made by Jack Monger, seconded by John Alvarado): Postpone the vote on the position letter to a later date, AND send a formal request to the Port of San Diego to postpone the Port's Board of Commissioners' consideration of the proposed Mitsubishi Cement Corporation (MCC) project EIR, Lease Agreement, and other project details to a future date to allow sufficient time for public input.
