**RESOLUTION OF THE GOVERNING BOARD OF THE SAN DIEGO COUNTY AIR POLLUTION CONTROL DISTRICT AUTHORIZING THE CONTINUATION OF AN INVESTMENT ACCOUNT IN THE SAN DIEGO COUNTY INVESTMENT POOL ADMINISTERED BY THE TREASURER-TAX COLLECTOR**

**WHEREAS**, the San Diego County Air Pollution Control District (“District”) is an independent local air pollution control district under the California Health and Safety Code; and

**WHEREAS**, the composition of the District Governing Board changed to include County, city and public members pursuant to AB 423 (Gloria, 2019) as of March 1, 2021, and as a result the District ceased to be part of the County organizational and fiscal structure; and

**WHEREAS**, due to the change in organizational structure, the District must enter into a formal agreement with the County of San Diego in order to continue its prior investment in the County Investment Pool; and

**WHEREAS**, Government Code Section 53684 allows local public agencies to deposit excess money in the County Treasury for investment purposes; and

**WHEREAS**, it is in the interest of the District to protect and maximize the earnings on excess cash;

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, as follows:

1. The District Governing Board does hereby authorize the continued deposit and withdrawal of District funds in the San Diego County Investment Pool in the County Treasury in accordance with the provisions of Government Code Section 53684 for the purpose of investment as stated in the San Diego County Treasurer’s Pooled Money Fund Investment Policy and subject to verification by the County Treasurer’s Office of all banking information provided in that regard; and
2. That the following District officers or their successors in office shall be authorized to order the deposit or withdrawal of funds in the San Diego County Investment Pool:
