 - If this application is approved, the old equipment and engine must be destroyed or rendered permanently inoperable in accordance with APCD requirements;
 - The replacement equipment must be new, not used or previously owned or factory reconditioned;
 - The replacement equipment must be purchased from a manufacturer-authorized retailer or dealer, including hardware and home improvement stores, either brick-and-mortar or online;
 - New zero-emission lawn and garden equipment purchased must be of the same type as the internal combustion equipment it replaces.
- I understand that this equipment must be operated for at least three years from purchase/delivery at a school that:
 - Is located in a disadvantaged community, as described by [CARB's Priority Population Map](#);
 - Is under the exclusive control of the officers of the public schools; and
 - Serves students in any grades from kindergarten through twelfth grade.
- I am including with this application:
 - Two quotes for the proposed replacement equipment, and
 - Documentation showing the replacement equipment would have at least a one-year manufacturer warranty.
 - A copy of the contract/agreement and/or a written consent form from the school acknowledging the applicant's participation in this program (unless applicant is the school).
