#### **PETITION BEFORE THE BOARD:**

**4516 NAVFAC Southwest:** As Permitted Party, Requests a Permit Appeal Hearing for Permit No.'s APCD2021-PTO-003675, APCD2021-PTO-003676, and APCD2021-PTO-003677 Pertaining to Annual Engine Maintenance Requirements and Recordkeeping in Support of Ship Repair and Maintenance Operations Located at Naval Base Point Loma, USN NAV Sta 3 Shore Int. Maint. Act and Naval Station San Diego, Respectively, in Accordance with Rule 25.

## ACTION:

ON MOTION of Member Smith, seconded by Chair Rodriguez, the Air Pollution Control District Hearing Board denied the Petitioner's request for an Appeal of Permit No.'s APCD2021-PTO-003675, APCD2021-PTO-003676, and APCD2021-PTO-003677.

Based upon testimony given and evidence provided, the Board determined that the Air Pollution Control District provided fair and reasonable application of Rule 69.4.1. and has consistently applied this Rule to multiple applicants since 2009. The Board determined that while both parties provided compelling arguments, the Petitioner did not provide evidence or the necessary information to grant the appeal based on good cause.

It is the position of the Board that the appeal must be denied due to consistent and reasonable application of Rule 69.4.1 by the Air Pollution Control District.
