APPROVAL OF REVISED AB2588 “HOT SPOTS” HEALTH RISK ASSESSMENT

As required by the California Health and Safety (H&S) code, section 44360, the San Diego County Air Pollution Control District (District) requested a Health Risk Assessment (HRA) from Vulcan Materials Western Division (Vulcan) on September 2, 2020 for the mineral industry operation at 10051 Black Mountain Road in San Diego based on emissions that occurred in calendar year 2017. Vulcan submitted a HRA to the District on March 1, 2021. The District provided our comments on the HRA along with comments provided from the Office of Environmental Health Hazard Assessment (OEHHA) to Vulcan on August 18, 2021. Vulcan submitted a revised HRA to the District on December 2, 2021. Subsequently, the District revised the HRA on February 22, 2022.

After considering the revised HRA provided by Vulcan on December 2, 2021, in accordance with the California Health and Safety (H&S) Code, Section 44362, the District is hereby approving the revised 2017 HRA with the following results:

Maximum Individual Excess Cancer Risk (PMI)	145.00 in a million
Maximum Residential Excess Cancer Risk	8.63 in a million
Maximum Occupational Excess Cancer Risk	1.15 in a million
Maximum Chronic Non-Cancer Health Hazard Index (PMI)	9.08
Maximum Residential Chronic Non-Cancer Health Hazard Index	0.53
Maximum Occupational Chronic Non-Cancer Health Hazard Index	1.20
Maximum 8-Hour Occupational Non-Cancer Health Hazard Index	0.27
Maximum Acute Health Hazard Index (PMI)	2.63
Maximum Residential Acute Health Hazard Index	0.72
Maximum Occupational Acute Health Hazard Index	2.63
Population Excess Cancer Burden	0.06
Sub-Chronic Lead Exposure Risk	<0.12 ug/m ³

The approved HRA results are used to determine public health risk notification and risk reduction requirements under District Rule 1210. The approved HRA results indicate that the Occupational Non-Cancer Chronic HHI and the Non-Cancer Acute HHI do exceed the public notification and risk reduction levels specified in District Rule 1210, sections (d)(1) and (e)(1), respectively.

Therefore, by April 8, 2022 (within 45 days of the date of this letter), your facility must submit a public notification plan that specifies the procedures you intend to use to notify the public and hold a public meeting within 30 days of District approval of the plan. Vulcan should work with the District to find a mutually agreeable date for the public meeting to be included in the provided public notification letter template. Prior to August 21, 2022, (within 180 days of the date of this letter, CCA must submit a risk reduction audit and plan that details methods that will be used to reduce the Non-Cancer Chronic HHI and the Non-Cancer Acute HHI, based on the results of the HRA. The required elements of the plan are described in District Rule 1210, Subsections (d)(2)(i) through (d)(2)(xi) and (e)(2)(i) through (e)(2)(vi), respectively.
