Regulations and the following conditions:

1. The asphalt roofing kettle or asphalt day tanker shall have an identification tag or serial number stamped, welded or engraved in a visible, accessible location on the kettle or tanker; shall not be operated above 525°F(274°C), and shall be equipped with a functional temperature gauge, temperature control thermostat and a lid which shall be closed at all times when the unit is operating except for loading asphalt. (Rule 12) (Rule 50)
2. The temperature gauge and temperature control thermostat shall be maintained on the equipment and shall be in good operating condition at all times. (Rule 50)
3. Tank or kettle interior temperature shall be lowered before opening the equipment prior to maintenance and cleaning operations in order to prevent violation of Rule 50.
4. Air contaminant emissions shall not be more dense than 20% (or number 1 on Ringelmann Chart) for more than three (3) minutes in any consecutive 60 minute period. (Rule 50)
5. Equipment shall not cause or contribute to a public nuisance. (Rule 51)
6. The registrant shall provide access, facilities, utilities and any necessary safety equipment for source testing and inspection upon request of the Air Pollution Control District. (Rule 19)
