- 1. Filters shall be in use and in good operating condition at all times when pneumatically transferring and receiving grain. (Rule 12)
- 2. Manufacturer's specifications or engineering data demonstrating a minimum particulate matter control efficiency of 90 percent by weight for PM10 shall be retained on site and made readily available to the District upon request. (Rule 12)
- 3. There shall be no leakage from silos and ducting prior to treatment by the filter. (Rule 12)
- 4. This equipment shall not discharge into the atmosphere from any single source of emissions, any air contaminant for a period or periods aggregating more than three minutes in any one hour which has an opacity such as to obscure an observer's view to a degree equal to or greater than does smoke of a shade designated Ringelmann 1 or equivalent 20 percent opacity. (Rule 12 and/or Rule 50)
- 5. Equipment shall not discharge such quantities of air contaminants or other material which cause injury, detriment, nuisance or annoyance to any considerable number of persons or to the public; or which endanger the comfort, repose, health or safety of any such persons or the public; or which cause or have a natural tendency to cause injury or damage to business or property. (Rule 12 and/or Rule 51)
- 6. Access, facilities, utilities and any necessary safety equipment for source testing and inspection shall be provided upon request of the Air Pollution Control District.
- 7. This Air Pollution Control District Permit does not relieve the holder from obtaining permits or authorizations required by other governmental agencies.
