NOTICE OF PUBLIC MEETING

FOR DISCUSSION OF IMPLEMENTATION OF NEW AIRBORNE TOXIC CONTROL MEASURE TO REDUCE EMISSIONS OF TOXIC AIR CONTAMINANTS FROM OUTDOOR RESIDENTIAL WASTE BURNING

The San Diego County Air Pollution Control District (District) will hold a public meeting to discuss the implementation of a new California Air Resources Board (ARB) statewide regulation entitled the *Airborne Toxic Control Measure (ATCM) to Reduce Emissions of Toxic Air Contaminants from Outdoor Residential Waste Burning*. Under the California Health and Safety Code, the District is required to enforce state airborne toxic control measures. Comments concerning local implementation of the control measure may be submitted in writing before, or made at, the meeting which is scheduled as follows:

On February 21, 2002, ARB adopted a new regulation (Section 93113, Title 17, California Code of Regulations) designed to reduce public exposure to dioxins and other toxics from outdoor residential waste burning statewide. Exposure to these toxic pollutants may cause cancer, immune system damage, and other health problems.

Beginning January 1, 2004, the regulation prohibits most outdoor burning of residential waste in a large area of eastern San Diego County where outdoor burning of residential waste is currently allowed with a valid permit. Dry, natural vegetation grown on the property can still be burned outdoors in open piles (but not in burn barrels) with a valid permit. The regulation applies to anyone burning residential waste outdoors in open piles, burn pits, burn barrels, or incinerators. Residential waste burning is defined as the disposal of combustible and flammable waste from a single- or two-family dwelling or residence by burning outdoors. It does not include agricultural burning or prescribed burning. Waste is defined by the regulation and includes all discarded solid, semi-solid and liquid materials. District Rule 101, Burning Control, already prohibits open residential burning in the western section of San Diego County.

- Prohibits, beginning January 1, 2004, most burning of residential waste outdoors in specified areas (those with a population density of more than three persons per square mile).
- Applies to many areas in the eastern section of the county where residential waste burning has been allowed in the past with a valid permit.
- Allows open burning of clean, dry vegetation waste in all unincorporated areas.
- Allows the burning of dry non-glossy paper and cardboard and the use of burn barrels and incinerators in unincorporated areas with population densities of three persons or less. (In addition to ATCM requirements, such burning can only be done on permissive burn days using a District-approved ignition device, and a Burn Permit is required before conducting any open, outdoor burning.)

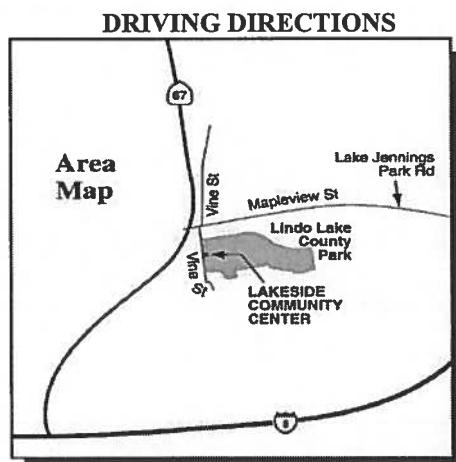
The District will provide an overview of the new regulation at the meeting. The District will also provide maps of affected areas and additional educational material regarding the regulation.
