NOTICE OF PROPOSED CHANGES TO TABLES I, II, AND III IN RULE 1200 AND RULE 1210 OF REGULATION XII BAN DIEGO COUNTY AIR POLLITION CONTROL DISTRICT RULES AND REGULATIONS

The Air Pollution Control District is proposing to revise Table I - Toxic Air Contaminants For Which Potential Carcinogenic Impacts Must Be Calculated and Table II – Toxic Air Contaminants For Which Potential Chronic Noncancer Impacts Must Be Calculated of Nule 1200 - Toxic Air Contaminants – New Source Review and Rule 1210 - Toxic Air Contaminant Public Health Risks Public Notification and Risk Reduction. These revisions mean that carcinogenic and chronic noncancer health effects of 12 diaxin-like polychlorinated biphenyls (PCB) will be considered in reviews of new, modified, and relocated sources emitting toxic air contaminants, as defined by Rule 1200. In addition, these compounds will also be evaluated when determining public notification and risk reduction requirements pursuant to Rule 1210. Calculation of health effects for these contaminants will be based on health standards recommended by CAPCOA guidelines (October 1993) or the California Office of Environmental Health Hazard Assessment (OEHHA). PCB containing sources have not been reported In San Diego County. According to the Callfornia Air Resources Board, among the potential sources of PCB are landfills containing PCB waste materials, destruction of articles containing PCB in municipal and Industrial waste disposal municipal and industrial waste disposal burners, and gradual wear and weathering of PCB containing products. Revisions to clarity the applicability of grouped substances are also being proposed for Tables I and I along with Table III - Toxic Air Contaminants For Which Potential Acute Noncancer Impacts Must Be Calculated, of Rule 1200 and Rule 1210. Written comments concerning these tables may be submitted for a period of 30 days, commencing April 1, 2004, and ending on April 30, 2004.
