NOTICE OF PUBLIC HEARING**

NOTICE, pursuant to the State of California Health and Safety Code Section 40725, is hereby given of a public hearing on February 12, 2026, at 2:00 p.m., before the San Diego County Air Pollution Control District Governing Board (Governing Board) in the County Administration Center, Room 302, 1600 Pacific Highway, San Diego, CA 92101, for the purpose of receiving public comments on and considering proposed amendments to Regulation X – Standards of Performance for New Stationary Sources and corresponding revisions to Appendix C. Pursuant to the Federal Clean Air Act (CAA), the U.S Environmental Protection Agency (EPA) establishes emission standards for various emission source categories. These emissions standards limit the amount of air pollutants entering the ambient air in order to protect public health and the environment. Section 111 of the CAA requires that EPA establish nationwide emission standards for new and modified sources, called New Source Performance Standards, or NSPS, whereas Section 112 of the CAA requires similar standards for existing sources of pollution, called National Emissions Standards for Hazardous Air Pollutants, or NESHAPs. Facilities must comply with all existing and applicable NSPSs and NESHAPs, though such requirements are typically incorporated into existing permits and/or local rules.

The District proposes to update Regulation X to incorporate new and amended NSPSs recently issued and finalized by the EPA to further protect air quality and public health. The proposed amended Regulation X will adopt by reference the current federal versions of the following Subparts of Title 40, Chapter 1, Part 60, of the Code of Federal Regulations (40 CFR Part 60): A (General Provisions), Kb (Standards of Performance for Volatile Organic Liquid Storage Vessels (including Petroleum Liquid Storage Vessels) for which Construction, Reconstruction, or Modification Commenced after July 23, 1984), Kc (Standards of Performance for Volatile Organic Liquid Storage Vessels (including Petroleum Liquid Storage Vessels) for which Construction, Reconstruction, or Modification Commenced after October 4, 2023), CCCC (Standards of Performance for Commercial and Industrial Solid Waste Incineration Units), EEEE (Standards of Performance for Other Solid Waste Incineration Units for which Construction is Commenced after December 9, 2004, or for which Modification or Reconstruction is Commenced on or after June 16, 2006), IIII (Standards of Performance for Stationary Compression Ignition Internal Combustion Engines), and JJJJ (Standards of Performance for Stationary Spark Ignition Internal Combustion Engines). If adopted by the Governing Board, the District will petition the EPA to receive updated delegation of authority to implement and enforce these federal standards in the San Diego region. District administration of federal standards helps facilitate local implementation and is preferred by both the EPA and regulated businesses. If recommended by the Governing Board, District staff will submit a request for delegation authority from the EPA to implement and enforce any new, repealed, or amended NSPSs. The Governing Board may consider modifications to the proposal, which may be deemed appropriate.

Additionally, as District delegation to enforce the NESHAPs is automatic, the District has included information within the corresponding Staff Report regarding relevant NESHAPs that have been recently modified to ensure stakeholders are aware of relevant changes at the federal level. NESHAPs that have been recently revised include A (General Provisions), R (Gasoline Distribution Facilities (Bulk Gasoline Terminals and Pipeline Breakout Stations)), ZZZZ (Stationary Reciprocating Internal Combustion Engines), and BBBB (Gasoline Distribution Bulk Terminals, Bulk Plants, and Pipeline Facilities).
