# FOR DISCUSSION OF DRAFT PROPOSED AMENDED RULE 19.2 – CONTINUOUS EMISSION MONITORING REQUIREMENTS

The San Diego County Air Pollution Control District (District) invites you to participate in the following online public workshop to provide input about draft amendments to Rule 19.2 – Continuous Emission Monitoring Requirements. Comments and questions concerning this proposal may be submitted in writing before or during the workshop, which is scheduled for:

Proposed amendments to Rule 19.2 apply to continuous emission monitoring systems (CEMS) that are required by the District, the U.S. Environmental Protection Agency (EPA) or the California Air Resources Board (CARB) and are subject to a gas concentration or emission rate standard. The amendments are being proposed to update the rule and to ensure it aligns with federal CEMS requirements in 40 CFR Parts 51, 60 and 75. The rule amendments will provide clarity to those subject to the rule when used in conjunction with federal regulations. In summary, the proposed amendments to Rule 19.2 specify:

- Quality assurance/quality control operating programs for CEMS
- Equipment sampling and recording frequencies
- Record keeping requirements for various data
- A requirement that data reports contain at least 95% of the source's operating hours
- Testing methods and a compliance schedule

Permit holders that operate CEMS are encouraged to distribute this workshop notice with contractor(s) that maintain their CEMS so they may also attend the workshop.
